

ZIPLINE LOGISTICS, LLC INTERNET PORTAL PRIVACY POLICY

Zipline Logistics, LLC (hereinafter Zipline) takes your privacy seriously. Please read the following to learn more about our privacy policy.

1. WHAT THIS PRIVACY POLICY COVERS

A. *General.* This policy covers how Zipline treats personal information that Zipline collects and receives, including information related to your use of Zipline products and services. Personal information is information about you that is personally identifiable such as your name, address, e-mail, or phone number, that is not otherwise publicly available.

B. *Companies and Individuals Not Controlled.* This policy does not apply to the practices of companies that Zipline does not own or control, or to people that Zipline does not employ or manage.

2. INFORMATION COLLECTION AND USE

A. *General*

1. Collection. Zipline collects personal information when you visit Zipline’s Web site or when you use Zipline products or services.

2. Information Sought. When you seek to use Zipline’s products or services, we may ask for information that includes your name, e-mail address, mailing address, telephone or facsimile number, birth date, gender, zip code, occupation, industry, and personal interests. For some services, Zipline may also ask for information about your assets. Once you visit Zipline’s website or seek to use any of Zipline’s products or services, you are not anonymous to us.

3. Products and Services. Zipline collects information about your transactions with us, including information about your use of the products and services we offer.

4. IP Address and Cookies. Zipline automatically receives and records information on our server logs from your browser, including your IP address, Zipline cookie information, and any web pages you may request.

5. Use. Zipline may use information for the following general purposes: to customize the content you see, fulfill your request for products and services, improve our products or services, contact you, conduct research, and provide anonymous reporting for internal and external clients.

B. *Children.*

1. By accessing Zipline's website or seeking to use Zipline's products or services, you represent that you are 13 years of age or older. If you are younger than 13 years old, please do not use the Zipline website or attempt to use Zipline's products or services. Your access to the Zipline website may be deleted if we believe that you are under 13 years of age.

C. *Information Sharing and Disclosure.*

1. Sharing of Personal Information. Zipline does not rent, sell or share personal information about you with other people or nonaffiliated companies except to provide products or services you've requested, when we have your permission, or under the following circumstances:

(a) We respond to subpoenas, court orders, or legal process, or to establish or exercise our legal rights or defend legal claims;

(b) We believe it is necessary to share information in order to investigate, prevent, or take action regarding illegal activities, suspected fraud, situations involving potential threats to the physical safety of any person, violations of Zipline's terms of use, or as otherwise required by law; and

(c) We transfer information about you if Zipline is acquired or merged with another company. In this event, Zipline will notify you before information about you is transferred and may become subject to a different privacy policy; and

3. **COOKIES**

A. *Rights Reserved.* Zipline may set and access cookies on your computer.

B. *Web Beacons.* Zipline may use Web beacons to access Zipline cookies inside and outside our network of Web sites and in connection with Zipline products and services.

4. **ADDITIONAL INFORMATION**

A. *General.*

1. Zipline Marketing and Newsletters. We reserve the right to send you certain communications relating to Zipline products or services, such as service announcements, administrative messages, or a newsletter, that are considered part of your Zipline account, without offering you the opportunity to opt-out of receiving them.

5. CONFIDENTIALITY AND SECURITY

A. *Limited Access to Information.* We limit access to personal information about you to employees who we believe reasonably need to come into contact with that information to provide products or services to you in order to do their jobs.

B. *Federal Compliance.* We have physical, electronic and procedural safeguards that comply with federal regulations to protect personal information about you.

C. *Protection.* Should you desire to open a Zipline Account, this account will be equipped with password protection.

D. *SSL Encryption.* In certain areas Zipline may use industry-standard SSL encryption to protect data transmissions.

6. CHANGES TO THIS POLICY

A. This policy may be updated from time to time at Zipline's sole discretion. Zipline will make every effort to notify you of any updates that are significant changes in the way we treat personal information by sending a notice to the e-mail address specified in your account.
